### Revision Description:

Adding Date Code changeover

### Description Of Change

The AD5755-1 digital block has been edited to address some digital anomalies.

Rev A: Adding Date Code to Product Identification Section.

### Reason For Change

On older silicon, when issuing a CLEAR during a two-stage readback could result in a lockup requiring a hardware reset to restore SPI communications. This has now been resolved. Other minor anomalies have also been fixed.

### Impact of the change (positive or negative) on fit, form, function & reliability

The fixes have resulted in changes to the timing specifications to ensure the robustness of the digital interface. These are highlighted in bold in the attachment.

The DICC specification also changes as follows:

Maximum: From 11mA to 6mA

Typical: From 9.2mA to 4mA

The new products will be identified by date code 1727 onwards.
